### MARKET ANNOUNCEMENT

#### - Dividend reinvestment plan

Free Bird Institute (FBL) wishes to advise its shareholders that under its Dividend reinvestment plan, shareholders have the opportunity to reinvest the interim dividends declared on 17<sup>th</sup> November 2021 into additional shares of FBL.

The premium price of the new issued shares will be \$3.09. The premium price is calculated by providing a 5% discount on the market price of the share at the date of the declaration.

Reinvestment into additional shares can be made without paying any brokerage fees.

Shareholders who wish to participate in the reinvestment plan will receive newly issued shares. The number of shares will be equal to the total amount of dividend to which the shareholder is entitled (\$0.75 multiplied by the number of shares owned) divided by \$3.09. The number of shares will be rounded down to the nearest whole number.

All registered shareholders as of 7th December 2021 can opt for the re-investment plan.

For any FBL share trades that happen from now until 01<sup>st</sup> December 2021, the buyer will be entitled to receive the dividend. For any trade that will happen after 01<sup>st</sup> December 2021, the seller will still be entitled to receive the dividend.
